Forms of Academic Assessments	Travis Elementary has common unit assessments that every teacher gives. Our school also uses interim assessments to assess student progress and growth in core subjects each semester of the school year. No matter the teacher, each child is assessed via the same assessment provided by Goose Creek CISD, which models each assessment after the State of Texas Assessments of Academic Readiness or STAAR test. Previous STAAR tests are released and utilized for assessment and instruction in addition to other curriculums.

Achievement levels on academic assessments	Travis Elementary tracks each child's growth throughout the year via local assessments (mentioned above).
