2024-2025 PARKING RULES

Parking permits give students the privilege of parking in the assigned parking areas if all rules and regulations concerning automobile traffic are obeyed. Students who cannot or will not abide by these rules may lose the right to bring their vehicle on campus.

Parking privileges are available to Sophomores, Juniors, and Seniors by completing this form AND QR code below.

1. Seniors, Juniors, and Sophomores may park in the IMPACT student parking area adjacent to the Lee H.S. Baseball Field.
2. IMPACT Students may only park in designated IMPACT student parking areas, and **all cars on campus must have a parking permit.**
3. A student driving an automobile to school will be required to have a valid Texas driver's license (not a Learner's Permit), proof of liability insurance, and a current parking permit properly displayed on the dashboard.
4. **A STUDENT WILL RECEIVE ONE PARKING PERMIT FOR ONE VEHICLE ONLY.** Permits are not transferable between vehicles.
5. If a student transfers a permit to another student or possesses another student's permit, it will be considered as giving false information. This may result in a conduct report and forfeiture of parking privileges for both parties.
6. **Students are not permitted in the parking lot at any time during the school day unless they have permission from a campus administrator.**
7. **Students who use their vehicles to leave campus without permission or transport students off campus who do not have permission from a parent/guardian may lose their privilege to park on campus.**
8. Students will not be permitted to sit in parked automobiles or congregate in the parking area at any time. This includes before school, during lunch, or after school.
9. Students are not to park in spaces reserved for staff members.
10. Please observe 10 M.P.H. speed limit at all times on GCCISD parking lot property.
11. Students who park on the Lee College campus must also obtain a Lee College parking pass.

Failure to comply with these rules will result in Parking Violations and Consequences. They are as follows:

1st Violation: Warning Sticker from GCCISD Police, Conduct Report in Review360, and parent/guardian contact
2nd Violation: Above + Loss of Permit for 2 weeks. ****If student is observed driving on campus during Loss of Permit, this will result in loss of permit for the rest of the semester.**
3rd Violation: Above + Car will be **"booted"** and student will be charged a **\$25.00 (cash only)** fee in addition to loss of permit for the entire school year. A booted vehicle must be paid by 3:30pm or vehicle will remain "booted" until the next school day.

Students who drive and park on GCCISD property need to fully understand the GCCISD drug/alcohol policy as it pertains to the searching of automobiles. Students who park on GCCISD property are subject to random drug testing as required by GCCISD.
